At the end of title V of division C, add the following:

6 (a) AUTHORIZATIONS OF APPROPRIATIONS.—Title
7 XXVI (42 U.S.C. 300ff-11 et seq.; commonly referred to
8 as the “Ryan White Comprehensive AIDS Resources
9 Emergency Act of 1990”) is amended—

10 (1) in section 2610(a)—

11 (A) by striking “and” after “fiscal year
12 2008,”; and

13 (B) by inserting “and an amount for each
14 of fiscal years 2010 through 2012 that is 3.7
15 percent greater than the amount authorized to
16 be appropriated for the preceding fiscal year”
17 before the period at the end of the first sen-
18 tence;

19 (2) in section 2623(a)—

1 (A) by striking “and” after “fiscal year
2 2008,”; and

3 (B) by inserting “and an amount for each
4 of fiscal years 2010 through 2012 that is 3.7
5 percent greater than the amount authorized to
6 be appropriated for the preceding fiscal year”
7 before the period at the end of the first sen-
8 tence;

9 (3) in section 2625(h), by striking “through
10 2009” and inserting “through 2012”;

11 (4) in section 2631(d), by striking “for each of
12 the fiscal years 2007 through 2009” and inserting
13 “for each of the fiscal years 2007 through 2012”;

14 (5) in section 2655—

15 (A) by striking “and” after “for fiscal year
16 2008,”; and

17 (B) by inserting “and an amount for each
18 of fiscal years 2010 through 2012 that is 3.7
19 percent greater than the amount authorized to
20 be appropriated for the preceding fiscal year”
21 before the period at the end of the sentence;

22 (6) in section 2671(i), by striking “for each of
23 the fiscal years 2007 through 2009” and inserting
24 “for each of the fiscal years 2007 through ²⁰¹²~~2009~~”;

25 (7) in section 2692(c)—

1 (A) in paragraph (1), by striking “for each
2 of the fiscal years 2007 through 2009” and in-
3 serting “for each of the fiscal years 2007
4 through 2012”; and

5 (B) in paragraph (2), by striking “for each
6 of the fiscal years 2007 through 2009” and in-
7 serting “for each of the fiscal years 2007
8 through 2012”; and

9 (8) in section 2693(a)—

10 (A) by striking “and” after “for fiscal year
11 2008,”; and

12 (B) by inserting “and an amount for each
13 of fiscal years 2010 through 2012 that is 3.7
14 percent greater than the amount authorized to
15 be appropriated for the preceding fiscal year”
16 before the period at the end of the sentence.

17 (b) HOLD HARMLESS PROVISIONS.—Title XXVI (42
18 U.S.C. 300ff–11 et seq.) is amended—

19 (1) in section 2603(a)(4)—

20 (A) in the matter preceding clause (i) in
21 subparagraph (A) and in subparagraph (C), by
22 striking “2009” each place it appears and in-
23 serting “2012”; and

1 (B) in subparagraph (A)(ii), by striking
2 “fiscal years 2008 and 2009” and inserting
3 “fiscal years 2008 through 2012”; and
4 (2) in 2618(a)(2)(H)—

5 (A) by amending the heading of clause (iii)
6 to read: “FISCAL YEARS 2008 THROUGH 2012”;

7 (B) in clause (iii), by striking “fiscal years
8 2008 and 2009” and inserting “fiscal years
9 2008 through 2012”; and

10 (C) in clause (v), by striking “2009” and
11 inserting “2012”.

12 (c) EXTENSION OF SUNSET PROVISION.—Section
13 703 of the Ryan White HIV/AIDS Treatment Moderniza-
14 tion Act of 2006 (Public Law 109–415; 120 Stat. 2767)
15 is amended by striking “October 1, 2009” and inserting
16 “October 1, 2012”.

17 (d) DISTRIBUTION OF FUNDS.—Title XXVI (42
18 U.S.C. 300ff–11 et seq.) is amended by adding at the end
19 the following:

20 **“PART G—DISTRIBUTION OF FUNDS**
21 **“SEC. 2695. DISTRIBUTION OF FUNDS IN ACCORDANCE**
22 **WITH FUNDING FORMULAS.**

23 “Notwithstanding any other law, the Secretary may
24 not distribute any funds appropriated to carry out this
