OFFERED BY Mr. Latta**

Page 90, line 12, insert “subject to paragraph (4),”
after “appropriated,”.

Page 91, after line 25, insert the following:

1 (4) PREVENTING ANY INCREASE IN NATIONAL
2 DEBT.—For each fiscal year the WTC program is in
3 existence, by a date specified by the WTC Program
4 Administrator, the Administrator shall certify that
5 the national debt for such fiscal year, as estimated
6 by the Director of the Congressional Budget Office,
7 is not greater than the amount such debt would have
8 been if the provisions of this Act had not been in ef-
9 fect for such fiscal year. As of the first date that
10 such certification does not apply, the WTC program
11 shall terminate and no amount shall be deposited
12 into the Fund for any remaining portion of the fiscal
13 year or any subsequent fiscal year.
