Actions by the FDA in instituting the ban on flavored cigarettes have caused a temporary negative impact on flavored cigars. Post SCHIP sales are slowly improving, assisted by the rollout of the Rillos products in a number of large accounts. The SCHIP tax increase was the principal cause of the decrease as tighter credit terms and the move by distributors to just in time inventories resulted in slower sales. Returned product further decreased sales numbers. Almost a half million dollars worth of the new Rillo product have been sold in the two and one half months since its introduction. Major accounts are planning to roll out the product in the coming months.






